

Silver Eagle Group Agreement of Terms & Conditions and Release from Liability

By signing the **Silver Eagle Group Acceptance of Firearm for Armorer's Work** form (hereafter referred to as the "Work Order"), I, the "Customer," acknowledge and accept all of the terms and conditions set forth herein, and acknowledge I have voluntarily requested of Silver Eagle Group activities which may include, but are not limited to, modifications and alterations to a gun/firearm which may affect various safety systems.

I am aware that alterations and modifications of a gun/firearm may be hazardous. I am voluntarily requesting these activities take place with full knowledge of the dangers involved which may include death, dismemberment, paralysis, or other injuries.

I hereby agree to accept any and all risks and verify this statement by placing my signature on the Work Order. I release Silver Eagle Group from any and all liability for any alterations or modifications that were made at my request. Furthermore, I warrant that I am not requesting alterations or modifications that will violate any city, county, state, or federal law(s).

As consideration for the armorers or gunsmiths performing work pursuant to my directions, instructions, and requests, I hereby agree that neither I nor my assignees, heirs, distributees, guardians, and legal representatives, will make a claim against, sue, or attach the property of Silver Eagle Group or any of its owners, employees, or affiliated organizations, for injuries or damages resulting from negligence or other acts of Silver Eagle Group, or any owner, employee, agent, or contractor of Silver Eagle Group, as a result from work modifications or alterations to any gun or firearm.

I hereby release Silver Eagle Group and any of its owners, employees, or affiliated organizations, from all actions, claims, or demands that I, my assignees, heirs, distributees, guardians or legal representatives now have or may hereafter have for injuries or damages resulting from any work performed by Silver Eagle Group.

I am informed, realize, and understand that any repairs or alterations which I have requested be done to my firearm, may release the original firearm manufacturer and/or importer from any and all liability for any injury or accident, should any occur.

I am informed, realize, and understand by reading and signing the Work Order, I am requesting repairs, modifications, corrections, or changes will be completed, and I am releasing the armorer(s), gunsmith(s) and any and all other Silver Eagle Group owners and its employees both individually and in any business form, from any and all liability should any malfunction or accident occur because of the work performed.

I indemnify and defend Silver Eagle Group and any of its owners, employees, or affiliated organizations from all liability for any loss, damage, or injury to persons or property arising from or related to the performance of the firearm including, without limitation, all liquidated and/or consequential damages, whether or not resulting from the negligence of the Customer or Customer's agent in using the firearm after modification or repair.

This agreement supersedes any and all other agreements, either oral or in writing, between the Customer and Silver Eagle Group with respect to the subject of this contract.

This contract contains all of the covenants and agreements between the parties with respect to the armory and/or gunsmithing work pursuant to the Work Order and each party to this contract acknowledges that no representations, inducements, promises or agreements have been made by or on behalf of any party, except those covenants and agreements embodied in this contract.

No Agreement, statement, or promise not contained in this contract shall be binding or valid. All terms of all agreements made between the Customer and Silver Eagle Group are fully integrated herein.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT FULLY. I FURTHER UNDERSTAND THAT BY SIGNING THE WORK ORDER, I VOLUNTARY SURRENDER CERTAIN LEGAL RIGHTS.
